
FDK Announces New Corporate Governance,

Business Management Structure

Tokyo March 11,2002-Following a meeting today of its board of directors, FDK Corp, Announced that it would undertake a reform involving in corporate governance structure, introduction of a corporate officer system, and organization change for fully pursuing "the growth strategy of FDK group" announced on January 30th, 2002, and strengthening the enterprise constitution. The detailed plan is as follows.

- 1. Reorganization of Board of Directors and Introduction of Corporate Officer System
 - Separating the function of the management supervision and operating execution, while introducing a corporate officer system aimed at reorganization of board of directors.
 - To maximize shareholder value and that of the group as integration, a streamlined Board of Directors consisting of less members will concentrate on carrying out management supervision functions.
 - For operating execution, abundant autonomy and authority will be empowered to the new corporate officers, and the operating execution responsibility will be clarified in order to increase the efficiency of enterprise management and accelerating the pace of progress.
- 2. Organization Change

To perform enterprise deployment effectively in accordance with the growth strategy of a FDK Group, organizations will be integrated from April 1, 2002 and operate as a whole after merger of Iwaki Electronic co.,ltd. as a 100% subsidiary.(see the following organization chart)
