

## FDK Announces Reorganization and Officers Reassignments

Tokyo, Japan February 26, 2004 – Following a meeting today of its Board of Directors, FDK announced the reorganization and officers reassignments, effective April 1 2004.

1. Reorganization


In order to establish an effective organization structure centering on production innovation movement and advancement in priority and concentration, the following reorganization is performed.

(1) Establishment of Manufacturing Evolution Division

Manufacturing Evolution Division is established to boldly promote production innovation in the all FDK group.

- (2) Reorganization of an effective organization structure for priority and concentration In order to further streamline and strength the operations, associated parts business (coil devices and micro inductor) will be integrated with Hybrid Module Business and Power System Business, which comprise the heart of FDK group. Moreover, Circuit Device Business will be abolished and at the same time Ferrite Business will be completely shifted to China.
- (3) Review of Corporate Function

In a medium- and long-term perspective of operations, Business Strategy & Planning Department, which is under the direct control of the President, is established to give supports to precise management in order to keep abreast of changes in the market. Moreover, Administration Planning Division is renamed as Administration Division which will support the operations of the group and reduce management cost by streamlining the organization.
